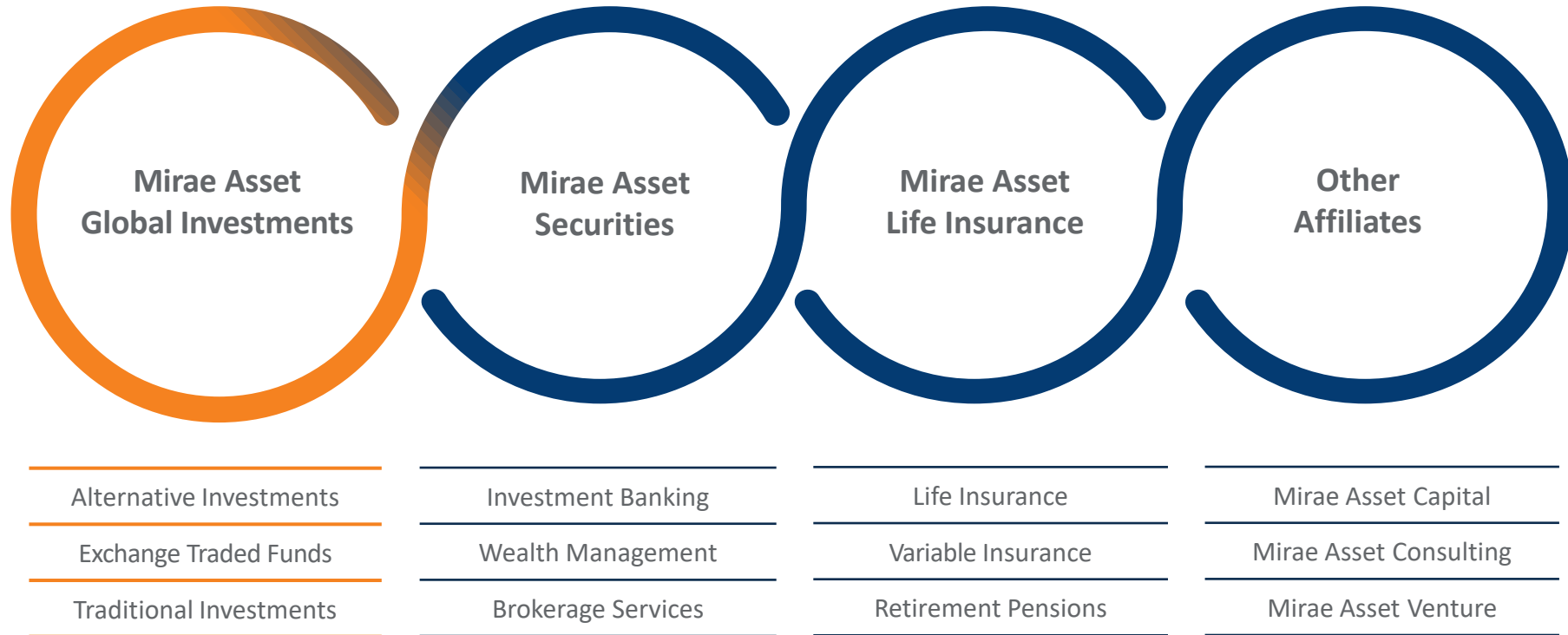

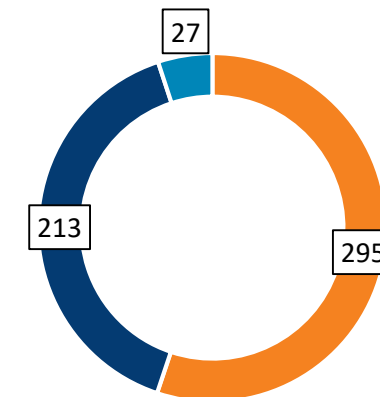

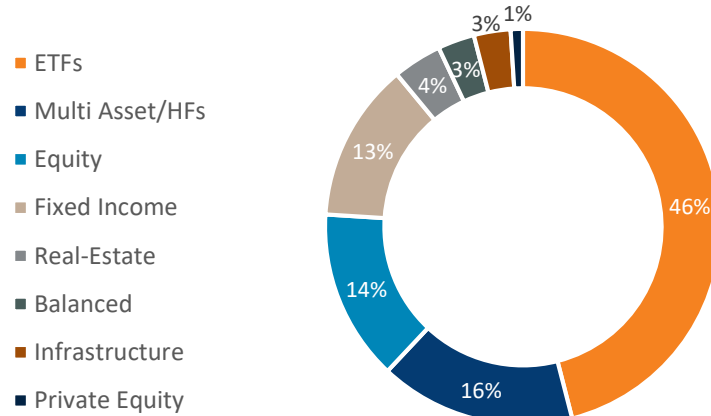

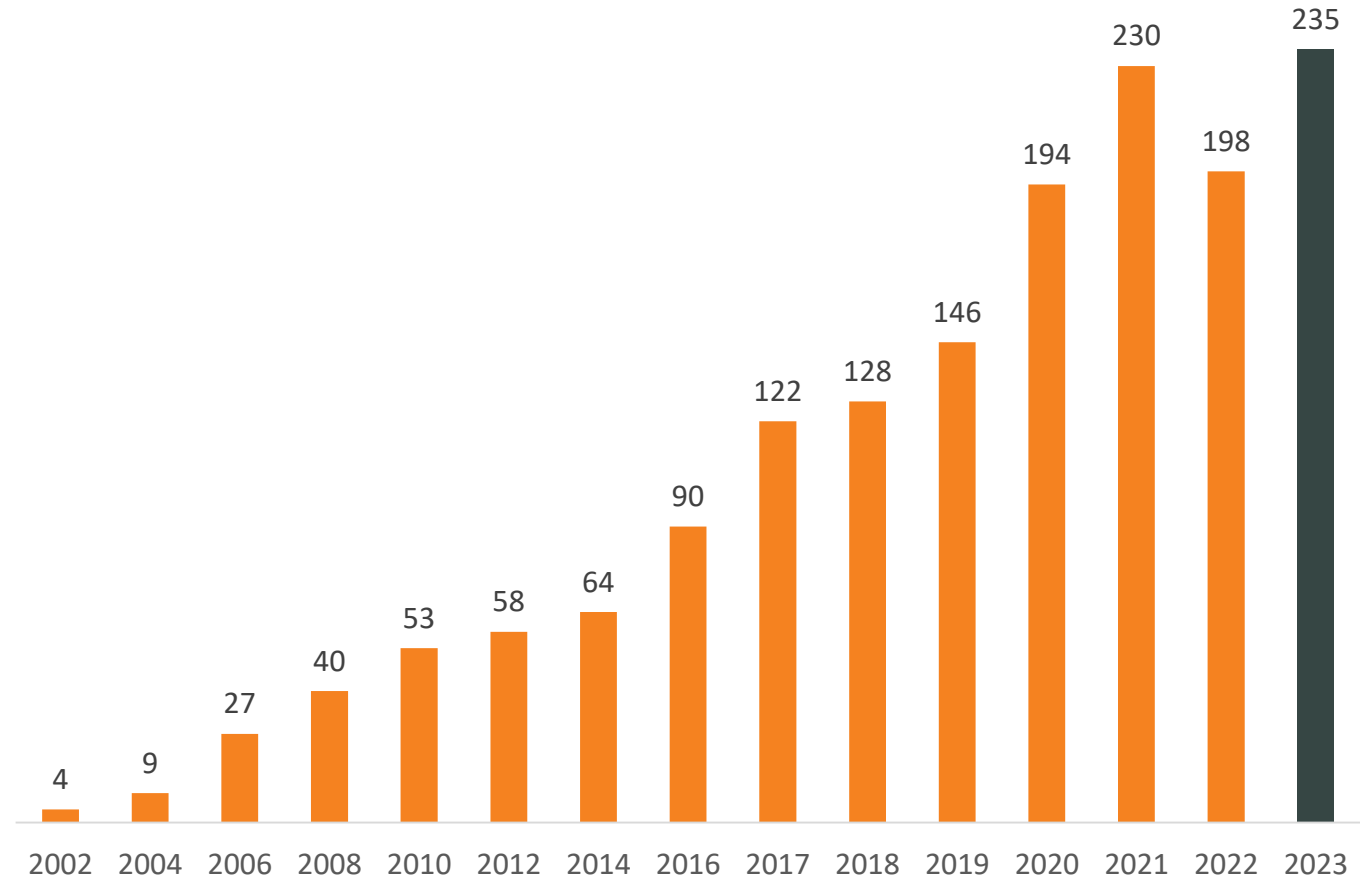
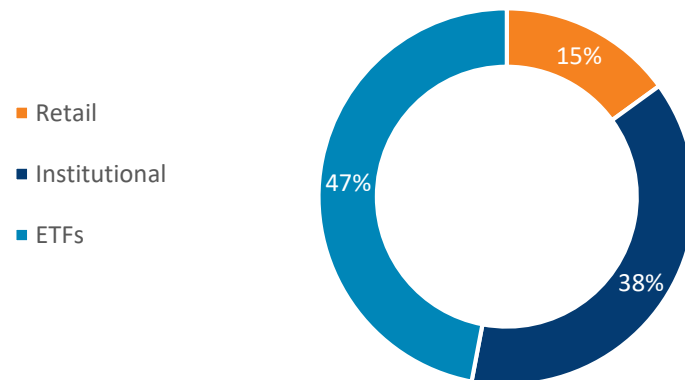

AUM Breakdown

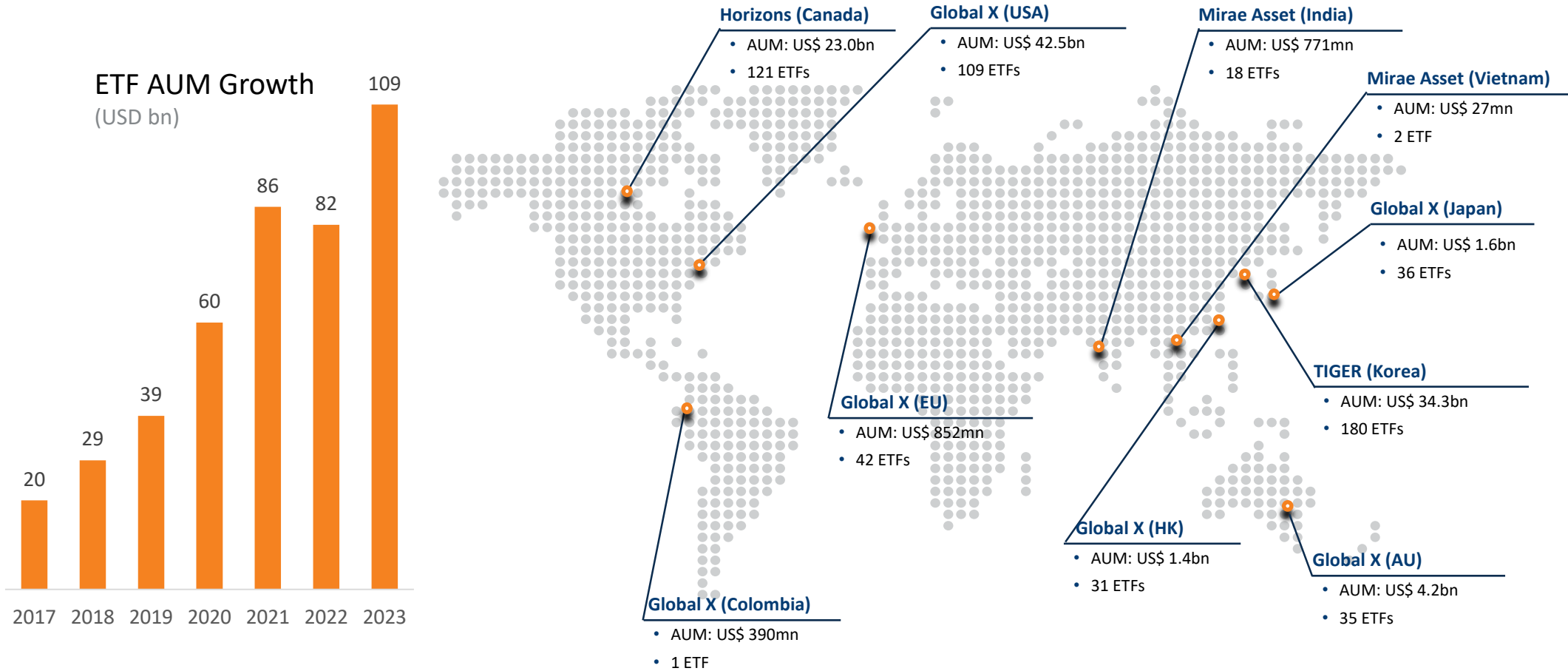


AUM by Client Type

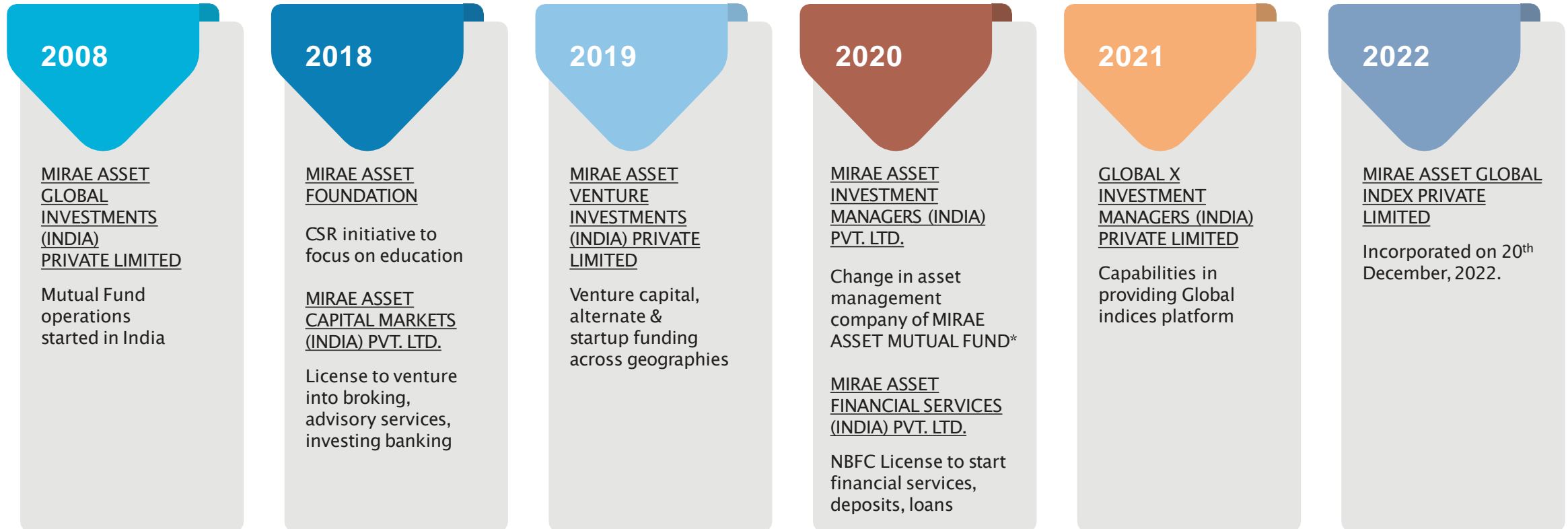

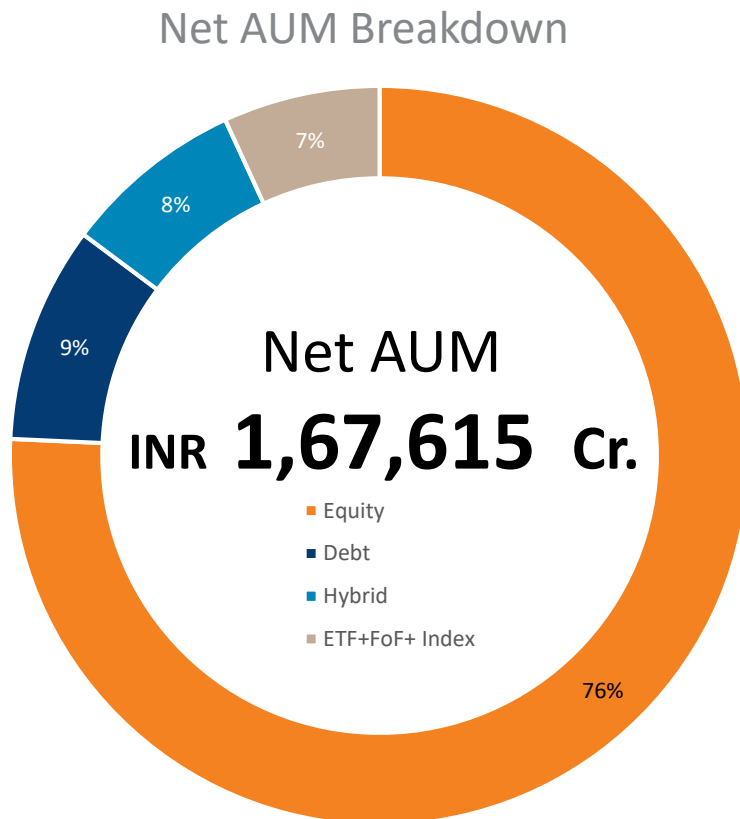

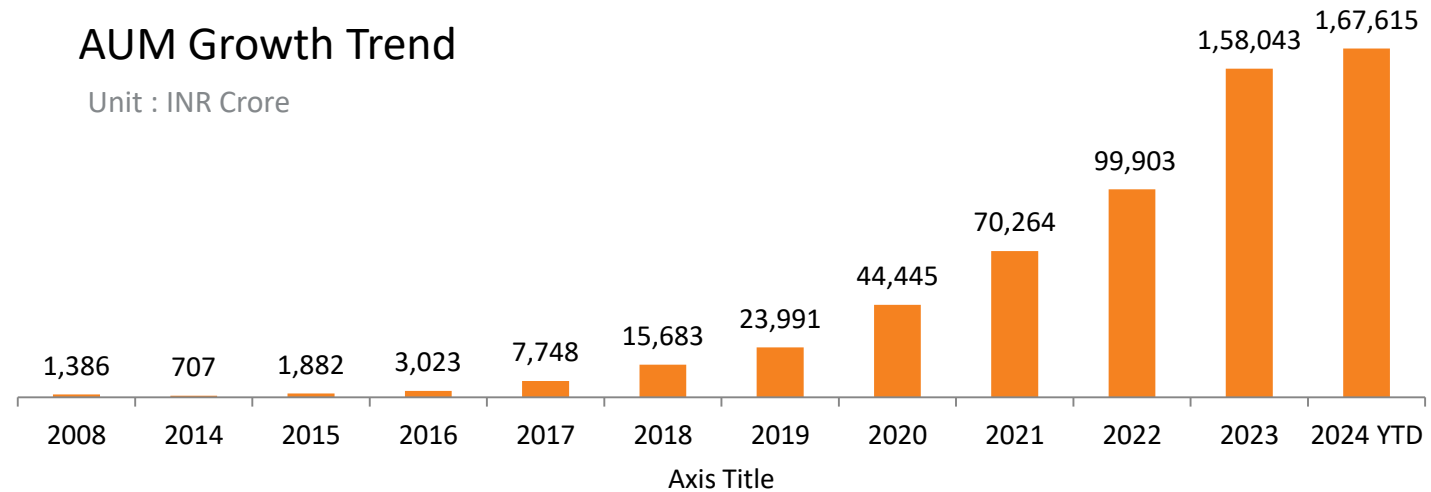

Mutual Fund AUM Growth



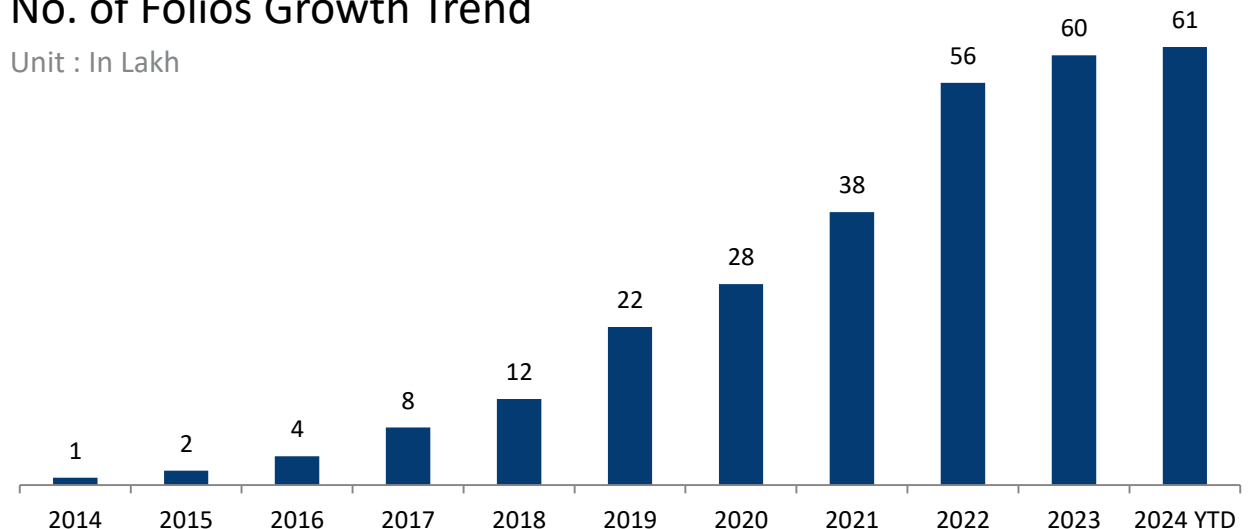
AUM Growth Trend

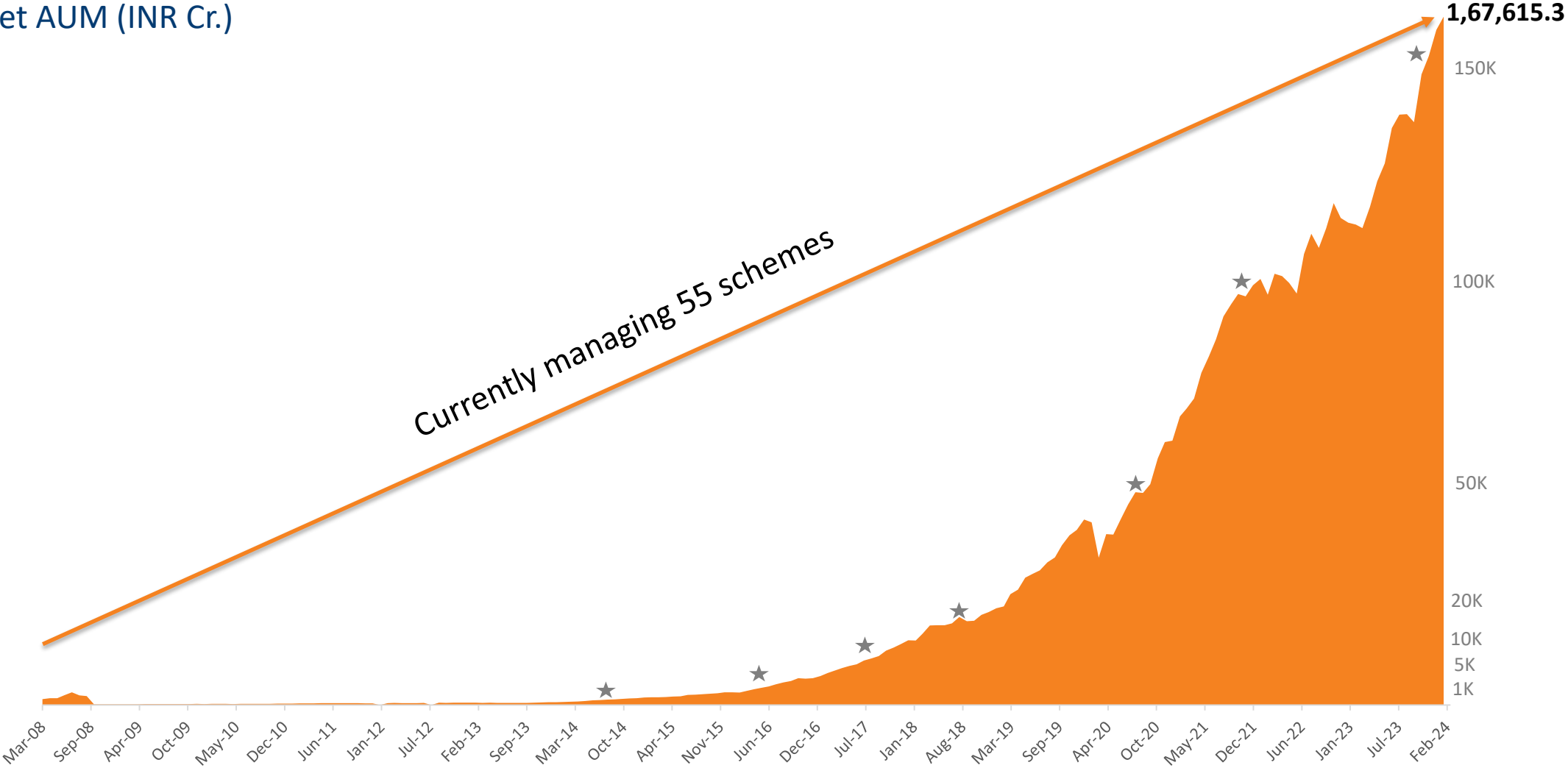
