
2021 Economy Review - a year of rebound

2021 - A swift, split, and stimulus-propelled global rebound year. Major economies were able to recover from the initial slowdown. However, just as the world was turning optimistic about returning to normalcy, having put the Delta variant surge behind, and with vaccination levels nearing the threshold, a new variant, Omicron, has brought about a fresh round of uncertainty.

At home, we faced the worst time from March to June due to the second wave of COVID-19; but, if we look at the end of the year, most of the restrictions are uplifted and macroeconomic data has gradually improved. Unlike, at the start of the year, India appears to be in a very strong position relative to the rest of the world led by improvement in vaccination rate and demand normalization.

Global economy and central banks

At the dawn of 2022, all major global central banks, including the Fed, seem to be entering into the monetary policy normalization phase, with the tapering being the most common starting point. This is in sharp contrast to 2021, when all the major central banks were committed to "lower rates for longer." Despite the new variants creating uncertainty, the yields have moved up as a result of central bank actions and economic recovery.



Macro data shows resilience

Global and domestic economy has shown remarkable resilience.US Jobless claims have improved from 787K to 222k. Also, PMI is up from 57.1 to 58.3 for the US and 55.2 to 58.5 for Eurozone. This recovery is despite the new variant led disruption and also higher crude prices which were up from a low of USD 19/bbl in 2020 to a high USD85/bbl in 2021 due to limited supply from OPEC+.

The Indian economy seems to be roaring back to the pre-pandemic levels despite the severe second wave, and appears to be poised for abovetrend growth in 2022 (GST collections consistently above INR1t, rail freight growing at 10-12% YoY, and property sales on an uptrend), assuming a normal scenario. With regard to economic growth, a marked improvement is seen, with GDP likely to grow 9-10% in FY22 (as per the IMF) from a sharp contraction in FY21.

Govt. action - prioritizing growth over fiscal

Growth has been a higher priority for fiscal as well as monetary authorities. The fiscal situation has been well-managed with a steady pace of expenditure, while tax revenues have been fairly buoyant. The government remains on track to meet the GFD/GDP target of 6.8% in FY22, without any additional borrowings v/s the budget estimates.

The external sector balance has remained comfortable, although the trade deficit has widened significantly over the last few months. Current account deficit came in at a surplus in 2QCY21 and moved back into deficit subsequently. The RBI's FX reserves of around USD635b, built through positive BOP through the year, provide a buffer against any sharp and sustained depreciation bias on the INR.

Proactive RBI actions

In 2021 as well, the RBI was extremely proactive and innovative in undertaking a series of actions to safeguard market stability by ensuring adequate liquidity and management of the yield curve. India stands out as, perhaps, the sole exception at the moment - at its December policy review, the RBI reinforced its ultra-loose accommodative stance, supported by relatively better behaved headline inflation, largely staying within its target band of 2-6% and armed with a strong forex kitty well in excess of USD600b (among the Top 5 in the world).

It now endeavors to restore the revised liquidity management framework instituted in February 2020 by actions through VRRR increased

pace and quantum. Inflation remains a concern

Inflation remains one of the key concerns this year as well. The unrelenting onslaught of inflation in the second half of 2021 - with the year ending at a nearly 40-year high reading of 6.8% on the headline CPI in the US, for example - has left central banks with little choice. However, uncertainties arising out of the highly transmissible Omicron variant, perhaps, warrant a bit more patience, so the solid gains from an accommodative policy



framework in the last two years, when the pandemic has ravaged the world, are not lost.


Inflation in India has surged to nearly 6%, closer to the upper band of the RBI threshold, due to a) supply-side disruption and b) a rise in the food, vegetable, and fuel components. However, at the start of 2021, inflation had moderated largely on favorable base effects, which started to rise yet again from May due to an increase in the food, energy, and core components. Inflation was back in the moderation phase from September on account of subdued food inflation. At the end of 2021, upside risks to inflation remained on account of the ongoing energy crisis, supply-side disruptions / pending price hikes, and adverse base effects.

During the year, while the yields have moved up across the tenures, the shorter end of the curve has moved up more aggressively led by VRRR auctions. This in turn has led to yield curve flattening much in line with the global yield curves.

In Lakh Crore

In the first half of the year, RBI undertook regular OMOs and injected additional liquidity under G-SAP 1.0. A purchase and sale auction under 'Operation Twist' was also conducted to facilitate the smooth evolution of the yield curve. The aim was to shift from time-based guidance to statebased guidance and soften interest rate policy for sustainable growth.

The second half of the year saw hardening of yields due to the indication of tapering and central banks' making a cautious move on policy normalization, leading to the flattening of the yield curve. Many central banks went for rate hikes and the Fed started tapering. Also, in its last Fed meeting, there was a readiness among the members to consider rate hikes in 2022.

Money Market yields that were trading near the reverse repo rate, started to shift towards the repo rate as the RBI moved ahead with liquidity normalization. Mid- and long-term yields gradually moved up over the course of the year owing to stable macroeconomics and US Treasury.

The biggest concern today seems to be the easy breakthrough tendency of the Omicron variant, even against those already infected or fully vaccinated. Hence, many nations are putting additional restrictions on travel and mobility; the broader indication is that there would be no mass scale complete shutdowns as those during the first wave, as also indicated by the US president at a press conference held just ahead of Christmas.

A new round of disruption by Omicron may result in further tenacity in inflation dynamics. Thus, at the global level, 2022 starts on a cautionary note due to Omicron, an optimistic note on account of economic momentum, and a concerning note due to inflation. So, the two questions that most will want an answer to right now are: 1) Will the ongoing taper eventually extend to multiple rates hikes later in 2022, as projected currently? 2) Will the RBI be able to maintain its standalone accommodative stance for long enough against the global trend?



Equity Market 2022 Outlook

We believe India has entered a period of strong economic and earnings growth. The key pillars for earnings growth are as follows:

Stable macros and reforms to improve growth: We believe India has entered a period of strong growth given the stable macros related to forex, current account, inflation, and interest rates. Moreover, supportive government policy and ongoing reforms - such as GST, IBC, RERA, labor laws, and the focus on manufacturing via PLI - would aid medium-term recovery.

Revival in Housing cycle: A decisive turnaround is seen in the Housing sector following a seven-year slowdown. The revival is attributable to the best affordability in two decades, driven by low interest rates and benign property prices.


Improvement in Banking sector: System-wide gross non-performing loans have reduced by 400bps in the last four years. We believe the reversal of the bad loan cycle should help improve profitability and lending capacity.

Formalization and consolidation: Multiple factors have led to consolidation in multiple sectors, with strong companies getting stronger and weaker ones being marginalized. The massive consolidation comes as a result of back-to-back events such as the demonetization, GST regime, digital acceptance, and various reforms. This consolidation is a positive for the Top 500 companies.


Improved outlook for IT sector: The IT sector has witnessed the best period recently owing to the front-loading of demand and cost savings in demand fulfillment. The sector would give best-in-a-decade salary increases, which is a positive for the Consumer Discretionary business.


Deleveraging: Corporate debt/equity has reduced from 1x to 0.6x in the last six years. We have particularly seen massive improvement in balance sheets in the Metals sector, which is not geared for new capex.

Improving corporate profitability and ROE: We believe corporate profitability is at an inflection point and would result in meaningful earnings growth. Corporate profit to GDP reached multi-year lows of 1.8% in FY20. Thereafter, it has now already improved to 3.5% and is likely to improve further. Resultantly, corporate ROE at 12.5% is at seven-year highs. rate profit to GDP ratio to improve

We are constructive on equities: Equity market returns are a function of earnings growth, valuation, interest rate, and flows. As mentioned above, India is on the cusp of achieving robust growth over the next few years. The Nifty index is currently trading at about 17x FY24E earnings, which is at an aggregate-level small premium to historical averages. However, we believe valuations are reasonable given the expectation of 22% earnings growth over FY20-24 as well as low cost of capital.

We believe domestic flows would remain strong given the low penetration of equities within household savings. FII flows would also improve over the medium term as India remains among the fastest growth economies.

We would advise investors not to time the market and invest in equities for the long term within their earmarked asset allocation in a disciplined way (based on one's risk profile). The staggered investments through SIPs or STPs would remain the best ways to invest in equities.

In the current market context, one can keep higher allocation towards largecaps and hybrid category funds, and have a relatively higher investment time horizon for midcaps and any sectoral funds.

Monitorable risks: COVID variants remain a key near-term risk - however, evidence of the infections having less severity, along with high vaccination rates in India, would help mitigate this risk. Apart from the customary oil price volatility, any disruptive Fed tightening and China-related events need to be monitored.

We believe valuations are reasonable given the expectation of 22% earnings growth over FY20-24 as well as low cost of capital. We are positive on discretionary, financials which would benefit in the recovery period and some relatively stable sectors like Healthcare, IT along with some B-B businesses and few value names.



Debt Market 2022 Outlook

Extrapolating the present trend would suggest that global central banks would follow through on the current tapering schedule with a shallow rate hike cycle. The market seems to price 3-4 rate hikes of 25bps each in the US. Although, the possibility of consistent disruption from Omicron or subsequent variants and a relapse into economic slowdown in the absence of further fiscal boost (such as seen in 2021) may not cause an aggravated tightening cycle, which may peak with rates still in accommodative zone.

After remaining abnormally high last year, a strong base effect and slowing momentum may result in headline inflation beginning to somewhat relent. The obsession central banks have with not tolerating any market disruption provides hope that the ongoing normalization process may be as disruptive as historically observed. As such, the consensus view in the global markets is that the curve would flatten. Broadly, analysts expect short-term rates to move up in line with the taper and rate hikes by the central banks.

As for India, the RBI's unequivocal guidance remains that of overarching support for sustainable growth, while keeping a hawk-eye on inflation. With strong and improving macro fundamentals domestically, the only factor that may divert regulators towards an accelerated tightening may have to come from an external sector. That may be faster than the currently projected global rate hike cycle, any major forex outflow from Indian markets, or any disruption in the emerging markets or similar.

The RBI has currently been calibrating system liquidity by gradually increasing the variable rate reverse repo auction amounts and extending the tenure that may shift the operative overnight rate towards 4% in due course. While it could be a de-facto rate hike of 65bps, it may allow the RBI to retain the flexibility to respond to the evolving situation without falling behind the curve. As such, the expectation is that liquidity would gradually normalize in 1H2022. Any possible repo rate hike may only come in the latter part of the year, going by the current guidance from regulators. Thus, we expect the yield curve to flatten, with short-term rates moving up more than long-term rates.


Looking at the scenario, the year ahead will likely continue to throw up volatility. Investors may look for the strategy with exposure at the shorter end (0 - 3 months) and medium end (3 - 5 years) of yield curve in line with their Investment horizon and risk appetite. This strategy will allow to take advantage flattening curve.

After a strong rebound in 2020, the markets continued their momentum in 2021 as well. The equity markets were buoyant as the earnings momentum was strong and priced in strong economic recovery and, consequently, strong growth in near-term earnings. An upbeat investor mood enabled strong participation in the primary markets from private companies.

In 2021, the equity markets witnessed a steady increase from May to October and were quite volatile towards the end of the year, gaining 24% CY21 (local currency), after gaining 15% YoY in CY20. 2021 can go down as the year of "Midcap and Smallcap" as Midcap100/ Smallcap100 outperformed the Nifty on account of the broader markets outperforming the largecaps in CY21.

Globally, India has outperformed peers (barring the US and Taiwan), including the Emerging Markets. In fact, had it not been for the recent Omicron concerns, returns would have been much higher. Also, the breadth of the market was encouraging as the median return in the BSE500 index was 43% in 2021, with 85% of the stocks yielding positive returns and 20% doubling during the year. Furthermore, returns were led by a change in earnings rather than valuation re-rating (as seen in 2020). Hence, to that extent, the year was better qualitatively.

The period saw net FPI inflow of USD3.8b (primary market inflow of USD10.8b and secondary market outflow of USD7b), while DII inflows stood at USD12b. In CY2021, 63 companies had raised USD15.4b from IPOs, the highest ever since 2017, when 36 companies had raised USD10.3b.

With regard to sectors, returns were mainly led by global cyclicals and IT, while domestic cyclicals such as Banks and Autos underperformed. The outperforming sectors saw sharp improvement in earnings as well as their balance sheets.

We anticipate global central banks to follow through on the current tapering schedule with a shallow rate hike cycle, but for RBI only external factor may divert regulators towards an accelerated tightening. Overall, we expect the yield curve to flatten, with short-term rates moving up more than long-term rates.

How to read a Mutual Fund Factsheet?




Know how your money is managed

The benefits of investing in mutual funds are well known. However, buying them on face value is not enough. Investors should know how their money is managed. They should research as much as possible on a scheme's strategy, performance, risks involved and how the money is invested. Many investors shy away from this exercise as they consider it cumbersome. To make life easy for investors, mutual funds disclose a fund factsheet which details the quintessential information required before investing.

The factsheet is a concise document with a plethora of information about how the fund is managed; it is disclosed on a monthly basis. This article tries to decode the factsheet and explains how investors should use it for making investment decisions.

Five things to look out for in mutual fund factsheets



Basic information

The factsheet provides all the general information on the fund – its objective or philosophy, options (growth or dividend), plans (direct and regular), net asset value (NAV) of each plan, minimum investment amount, systematic features (SIP, SWP, STP) and assets under management (AUM) data.

It is important to know about the fund's exit load, as it gets deducted from total gains if the investor exits during a specific period after investment. It is a small penalty charged on prevailing NAV to discourage premature redemption. Different schemes have different exit loads, while few such as Overnight funds generally do not have exit load. Some funds have a fixed exit load and some have a tiered structure. For instance, a fund may have nil exit load if the investor withdraws up to 10% of units per year. For units more than 10%, it charges 3% for exit before 12 months, 2% for exit before 24 months, 1% for exit before 36 months and nil after that.

Investors should look out for the fund's product labeling and riskometer. Product labeling underlines product suitability for investors. It tells about ideal investment time frame required to benefit from the fund and where it invests. Riskometer is a presentation that helps investors measure the risk associated with the fund. It presents six levels of risks - low, Low to Moderate, moderate, moderately High, High and Very High. Since an equity fund typically has high risk involved, needle of the scale points towards moderately high /high, suggesting the fund is meant for investors with a high risk-taking appetite. Examples of equity and liquid funds are listed below:

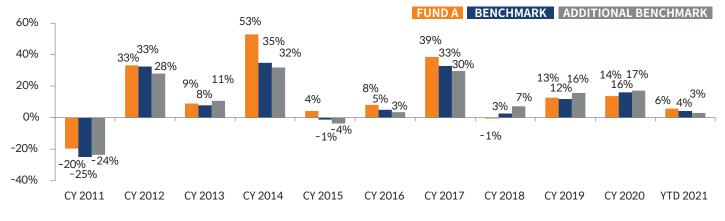

Fund manager details

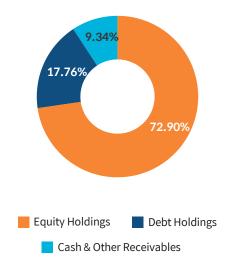

Portfolio aspects

Key portfolio attributes to look for in equity/ hybrid funds

🕞 Asset allocation

It highlights the exposure to different asset classes - equity, debt and cash - in a portfolio.



The factsheet provides information on the manager's experience and qualification. You can find out their track record by reviewing the performance of all schemes managed by them.

Company and sector allocation

It informs investors about a fund's concentration level in sectors and stocks. An aggressive fund manager may have high concentration among fewer companies and sectors, which may not be appropriate for investors seeking diversification. Investors should check whether the fund has taken higher-than-prudent exposure to risker sectors or low quality stocks.

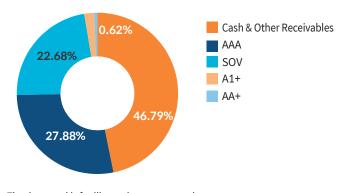
Key portfolio attributes to look for in debt funds

<u>Credit quality profile</u>

A debt fund's holdings are classified according to its credit ratings such as AAA, AA+, A1+ (given by credit rating agencies), etc.

Funds with higher exposure to AAA (top rated long-term debt) and A1+ (top rated short-term debt) have lower credit risk and higher credit quality.

Conservative investors should check whether the fund manager in order to boost performance is taking undue exposure to lower rated debt papers as they typically trade at higher yields but are exposed to high credit and liquidity risk vis-à-vis top rated papers.

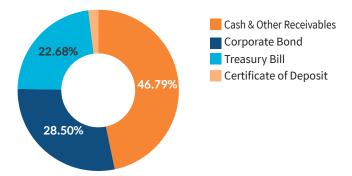

It highlights allocation to various debt instruments such as commercial papers (CPs), certificate of deposits (CDs), NCDs and bonds, gilts and cash equivalents.

Investors in shorter maturity debt funds such as liquid, ultra short term, short- term debt funds should check whether higher proportion has been allocated to shorter maturity instruments such as CPs and CDs. Sharpe Ratio:

Sharpe Ratio is a risk to reward ratio, it measures portfolio returns generated in excess to the investment in risk-free asset, for per unit of total risk taken. While, positive Sharpe ratio indicates, portfolio compensating investors with excess returns (over risk-free rate) for the commensurate risk taken; negative Sharpe ratio indicates, investors are better off investing in risk-free assets.

Beta:

A formula that expresses the measurable change in the value of a security in response to a change in interest rates. Modified duration of portfolio can be used to anticipate the change in market value of portfolio for every change in portfolio yield.

Macaulay Duration (Duration):

Macaulay Duration (Duration) measures the price volatility of fixed income securities. It is often used in the comparison of interest rate risk between securities with different coupons and different maturities. It is defined as the weighted average time to cash flows of a bond where the weights are nothing but the present value of the cash flows themselves. It is expressed in years/days. The duration of a fixed income security is always shorter than its term to maturity, except in the case of zero coupon securities where they are the same.
