Monthly Equity Market Insight



July 2023

EOUITY UPDATE

- Nifty-50 (+2.9%) tagged along with global rally to come close to the 20,000 level, even as Foreign Institutional Investor (FII) inflows slowed down and Domestic Institutional Investors (DIIs) turned net sellers.
- Mid-cap and Small-cap indices outshined Large-cap index and were up by 5.5% and 8%, respectively. Sector-wise, almost all indices ended in green, with power (+9%), realty (+9%) and capital goods (+8%) gaining the most.
- Globally, Russia (+7%), Hong Kong (+6%) and Malaysia (+6%) were the top gainers.

Global Macros

- Fed resumed rate hike: It's the 11th rate increase since the Fed began its inflation fight in March 2022, and comes just one month after the central bank hit pause in order to assess the state of the economy after the failures of three regional banks. The US Federal Open Market Committee hiked the target range of Federal Funds rate by 25bps to 5.25-5.50%. The midpoint of that target range would be the highest level for the benchmark rate since early 2001. Fed officials are estimating one more rate hike this year, according to their latest set of projections. Inflation's steady slowdown in recent months has been encouraging for American consumers and businesses, but officials reiterated in their post-meeting statement that "inflation remains elevated" and that the Fed "remains highly attentive to inflation risks," suggesting that another rate hike remains on the table.
- **Fitch cuts US credit rating:** Fitch downgraded the United States to AA+ from AAA, citing fiscal deterioration over the next three years and repeated down-the-wire debt ceiling negotiations that threaten the government's ability to pay its bills.
- Japan Yield Curve Controls: The Bank of Japan (BOJ) has tweaked its bond yield control policy and will allow interest rates to rise more freely, action that market participants have interpreted as the start of a slow shift away from decades of massive monetary stimulus. Since 2016, the BoJ has guided short-term interest rates at minus 0.1% and the 10-year government bond yield at around 0% in action known as Yield Curve Control (YCC). It has also set an allowance band of 0.5% above and below the 10-year yield target. Market expectations would now be for the BoJ to widen the bands by year-end and eventually give up the YCC policy by next summer. Economists warn that even a small shift to policy normalization may prompt Japanese cash to flood out of global markets and back home.
- Bond yield: The US 10-year bond yield increased to 3.96% as on July 31, 2023, from 3.84% as on June 30, 2023.
- Crude: Brent Oil is up 12% MoM on China stimulus and extension of production cuts by Saudi Arabia and Russia.

Domestic Macros

- Growth: IMF raised India's 2023 growth prospects to 6.1%, a 0.2%-point increase from April. This positive revision was due to the momentum gained from stronger-than-expected growth in Q4FY22 driven by robust domestic investment
- Credit Growth: As per latest RBI data, system credit growth stood at 20.2% YoY (14.4% YoY excluding the impact of the HDFC-HDFC Bank merger) for the fortnight ended July 14, 2023.
- Inflation: June 2023 Consumer Price Index inflation surged to 4.81% (4.31% in May 2023) and also increased sequentially by 1% led by vegetables (mainly tomato prices), meat and fish, pulses, and eggs. June 2023 Wholesale Price Index inflation contracted by 4.1% from (-)3.5% in May 2023 led by favorable base effects and continued softening in commodity prices.
- Currency: USD-INR has depreciated to ₹82.25/US\$ (as on July 31, 2023) from ₹82.04/US\$ (as on June 30, 2023) amid recovery in Dollar strength. On an average, however, the INR has appreciated by 0.1% against the US\$ in July 2023
- GST Collection: GST revenue collection in the month of June 2023 was at ₹1.65 lakh crore, up by around 11% on an annual basis. With this, the monthly GST revenues has remained over ₹1.4 lakh crore for 17 months in a row.
- Monsoon: Monsoon began on a weak note in June 2023 but the strong intensity of rainfall in July 2023 has pushed South-West monsoon higher at 6% (above LPA i.e. Long Period Average) till 30 Jul 2023. Region wise, Eastern and North Eastern region has received lower rainfall, while North Western region has recorded higher rainfall. Overall Kharif sowing has witnessed healthy recovery during July 2023 (flattish YoY) but due to erratic weather sowing of pulses is 11% YoY. El Nino risk of monsoon remains.

Regulatory, policy and market developments

Equity trading trends: Foreign Portfolio Investors bought US\$3.3 billion (until July 28, 2023) of Indian equities in the secondary market, whereas DIIs sold US\$325 million (until July 31, 2023).

• Nifty 1QFY24 earnings - Interim Review: In-line; BFSI and Auto drive the quarter: - Profits of the 33 Nifty-50 companies that have declared results so far have risen 43% YoY. The earnings have been in-line and was once again propelled by domestic cyclicals, such as BFSI and Auto sectors.


BFSI sector recorded a 42% YoY growth while Auto sector registered a profit of INR 102 billion (vs. a loss of INR 29 billion in 1QFY23)

Oil and Marketing Companies (OMCs) profitability surged to INR 243 billion in 1QFY24 vs. a loss of INR 83 billion in 1QFY23 due to strong marketing margins. Ex-OMC, Nifty's earnings rose 22% YoY.

Metals sector continued to drag the aggregates with a 64% YoY decline in earnings.

- Sectoral summary Technology: IT Service companies reported weak performance in 1QFY24 with flattish median revenue growth QoQ in constant currency, in an otherwise seasonally strong quarter. The weakness in key verticals continued through 1Q with BFSI and Retail reporting a median USD revenue decline of 1.2% and 0.4% QoQ, respectively.
- Banks: Earnings growth remained steady even as margin trajectory has turned across several banks. Asset quality continued to improve while Special Mention Accounts and restructured pool remained in control.
- Automobiles: Initial set of results has been a mixed bag. Volume offtake was muted in Commercial Vehicles (due to pre-buying in 4QFY23) and tractors; while domestic 2 Wheelers remained stable.
- Consumer: Aggregate sales stood in line with estimates, but EBITDA/PAT exceeded expectations led by correction in commodities. The aggregate FMCG sector posted muted YoY volume growth.


Chart of the month: Monsoon now at surplus

Outlook

Seasonally strong period ahead: Indian economy, typically fairs better in 2nd half of financial year, given the multiple festive occasions. This year too, the seasonality could play out, in our view. Further, given the general elections next year, it will be busy on the news flow front. As an investor, we continue to focus on the datapoints, which for now appears to be strong.

Cement production growth of 15% and Steel consumption growth of 14% were among the strongest indicators seen.

Domestic tractor sale +11% YoY for July 2023 has been showing a rising trend for the past 3 months. Await recovery on the domestic 2-Wheeler sales though.

Housing stats have kept climbing and are now nearing a 10-year-high. Property registrations showed mixed signals with Mumbai improved 4% MoM while Delhi seeing down.

The GST e-way bill generation for June 2023 at +16% YoY, was -4% MoM, on higher base.

Forex reserves have risen by US\$11 billion MoM and Forex cover is reasonable at 11 months level.

- Cyclical rebound helping India: Equity markets have faced 4 consecutive shocks in the last 2 years in the form of 1) COVID, 2) High inflation (disruption in global supply chains), 3) Geopolitics (Russia-Ukraine war) and 4) Sharp rise in interest rates. Indian economy has been able to withstand these shocks relatively better vs other economies. This is led by a) Cyclical upturn in many sectors (Real estate, Auto, Banking, Telecom etc), b) Manufacturing tailwinds led by China+1 & PLI, c) Capex recovery (India Inc. Balance Sheets have strengthened) and d) Consolidation (formalization).
- Key things to watch out are: (a) Oil price trend, (b) rate trajectory by the central banks, (c) Russia-Ukraine war and its impact on global supply chain and (d) Risk of El Nino on monsoons.
- Over the medium term: we continue to remain constructive on equities and believe India is on the cusp of achieving robust growth over the next few years. Higher capex provisioning and benefits from PLI (potentially can add 1.5% to GDP over the next 5 years) could potentially revive overall capital expenditure across the sectors, boost employment as well as credit growth.
- Valuation and view: India's medium to long term growth prospects remain strong. While markets are at fresh all-time highs, valuations are reasonable at ~19x on FY25 earnings. While domestic macro gives support at a broader level, at a sectoral level several financials, select autos, and pharma trade at a discount to historical average valuations.

DEBT UPDATE

Executive Summary

In 2022 central banks across the globe had set out to control a common challenge: Inflation. A year after the steepest rate hike, the challenges are stemming differently for economies. While inflation has peaked in most economies the challenges have changed. For instance: Strong Labor Market for US, Slowdown in Manufacturing for Eurozone and Food inflation for India. We saw unanimous policy actions until Mar-23, going forward we may see each central bank's decision based on domestic pain points. Therefore, going forward policy drivers could be different for different economies.

For India, there are two factors which could pull industrial performance down in the coming months. First being slowing global economy, which is already impacting exports. The second, monsoon- if its performance is sub-par. Monsoon is, therefore, a key monitorable from the perspective of food inflation, as well as for the forthcoming monetary policy.

Global Macros

Globally, three central banks took policy decisions in July-23. Starting with US Fed increasing policy rate by 25 basis points (bps) to 5.50%, highest in 22 years. European Central Bank (ECB) hiked its policy rate by 25 bps bringing its policy rate to 4.25%. The Bank of Japan (BOJ) decided to bend its long-running yield curve control (YCC) policy. It made range for 10Y Japanese government bond yield more flexible. The move marks a potential shift in BOJ's ultra-dovish stance as the bank also flagged substantially higher inflation in coming two years. While inflation has come down for most economies, it is still well above target level of 2% for most developed economies. Hence the hawkish stance by policy makers.

The path to a US soft landing widened a little more as Q2 2023 gross domestic product (GDP) growth surprised positively. The GDP growth in the US accelerated to 2.60% (YoY) in Q2 from 1.8% in Q1 of 2023. The other most important story indicating a soft landing is clear revival in US consumer confidence metrics over the last several months. The containment of the banking turmoil, the avoidance of a debt ceiling crisis, and the visible moderation in inflation have been key drivers of improvement. By the Sept-23 FOMC meeting, there will be two more employment reports and two more inflation reports to sift through. And as Chair Powell mentioned in July-23 FOMC, the next policy rate decision will lie on totality of incoming data. It would be interesting to see how the US economy acts for the Fed to react.


The story is more downbeat in the Eurozone, where the manufacturing Purchasing Managers Index (PMI) slid to 42.7. As output, new orders and employment, all contracted at faster rates. The services PMI eased to 51.1, with incoming new business now contracting, backlogs shrinking, and employment slowing sharply. Price pressures are easing but remain fairly intense.

US Treasury yields were quite volatile during the month. As a reaction to global events like decrease in UK Inflation and increase in US Fed dot plot, it moved south & north on several occasions. However, the US treasury yield curve still stands inverted with short term yields higher than long term.


On the commodity side, energy prices jumped led by natural gas and oil. Precious metals like gold and silver remained range bound at around previous month levels. Selected metals saw a surge in prices led by timber and iron.

The Dollar Index, which measures the greenback's strength against a basket of six currencies, displayed resilience. Among advanced economy currencies, the British pound continued to display strength. Japanese yen fell the most but gained as the Bank of Japan revised its yield curve control policy. In Eurozone weaker growth data from Germany - a key economy, led to depreciation of the euro.

Domestic Macros

The latest round of data presents a mixed picture of the economy. While industry performed well, inflation rose faster than expected and exports shrank 22% YoY in Jun-23. Moreover, monsoon, although normal, has been quite uneven in its spread over time and geographies.

Industrial production (IIP) logged 5.2% growth in May-23, very much in line with what the Purchasing Managers Index (PMI) in the strong expansion zone at 58.7 indicated. PMI at 57 in Jun-23, although lower than previous, implies healthy manufacturing growth in Jun-23 as well. Inflation at 4.8% in Jun-23 came in higher than expected, largely due to a spike in inflation in pulses and vegetables. This comes on the back of double-digit inflation in cereals and spices.

The key risk to inflation, particularly food inflation is from monsoon, which has been uneven so far. On the other hand, wholesale price index (WPI) linked inflation remained negative for the third consecutive month, declining to -4.12% in Jun-23 from -3.48% in May-23. This is the lowest since October 2015.


Commentary on Events

Systemic liquidity remained in surplus in July-23, due to the return of Rs 2,000 banknotes, FPI inflows and higher government spending. Lending rates remained relatively stable which hints that the transmission of rate hikes to lending rates is almost complete. Domestic financial conditions improved driven by foreign portfolio investor (FPI) inflows that reached a 10-month high. Debt FPI inflows surged to a 21-month high of \$1.12 billion.

Debt Outlook

Domestic yields tracked the surge in US treasury yields even as several domestic factors exerted downward pressure. Resultantly, yields across maturities moved upward in July-23.

The hardening of domestic yields comes from rising US treasury yields and increasing interest rates in major advanced economies amidst a halt in policy rate hike in India. Case in point being, 10Y G-sec yields which reversed course after trending downwards for previous two consecutive months. For now, the yields look range bound.

How to read a Mutual Fund Factsheet?



Know how your money is managed

The benefits of investing in mutual funds are well known. However, buying them on face value is not enough. Investors should know how their money is managed. They should research as much as possible on a scheme's strategy, performance, risks involved and how the money is invested. Many investors shy away from this exercise as they consider it cumbersome. To make life easy for investors, mutual funds disclose a fund factsheet which details the quintessential information required before investing.

The factsheet is a concise document with a plethora of information about how the fund is managed; it is disclosed on a monthly basis. This article tries to decode the factsheet and explains how investors should use it for making investment decisions.

Five things to look out for in mutual fund factsheets




Basic information

The factsheet provides all the general information on the funds its objective or philosophy, options (growth or dividend), plans (direct and regular), net asset value (NAV) of each plan, minimum investment amount, systematic features (SIP, SWP, STP) and assets under management (AUM) data.

It is important to know about the fund's exit load, as it gets deducted from total gains if the investor exits during a specific period after investment. It is a small penalty charged on prevailing NAV to discourage premature redemption. Different schemes have different exit loads, while few such as Overnight funds generally do not have exit load. Some funds have a fixed exit load and some have a tiered structure. For instance, a fund may have nil exit load if the investor withdraws up to 10% of units per year. For units more than 10%, it charges 3% for exit before 12 months, 2% for exit before 24 months, 1% for exit before 36 months and nil after that.

Investors should look out for the fund's product labeling and riskometer. Product labeling underlines product suitability for investors. It tells about ideal investment time frame required to benefit from the fund and where it invests. Riskometer is a presentation that helps investors measure the risk associated with the fund. It presents six levels of risks - low, Low to Moderate, moderate, moderately High, High and Very High. Since an equity fund typically has high risk involved, needle of the scale points towards moderately high /high, suggesting the fund is meant for investors with a high risk-taking appetite. Examples of equity and liquid funds are listed below:





An aggressive fund manager may have high concentration among fewer companies and sectors, which may not be appropriate for investors seeking diversification. Investors should check whether the fund has taken higher-than-prudent exposure to risker sectors or low quality stocks.


Key portfolio attributes to look for in debt funds

Credit quality profile

A debt fund's holdings are classified according to its credit ratings such as AAA, AA+, A1+ (given by credit rating agencies), etc.

Funds with higher exposure to AAA (top rated long-term debt) and A1+ (top rated short-term debt) have lower credit risk and higher credit quality.

Conservative investors should check whether the fund manager in order to boost performance is taking undue exposure to lower rated debt papers as they typically trade at higher yields but are exposed to high credit and liquidity risk vis-à-vis top rated papers.

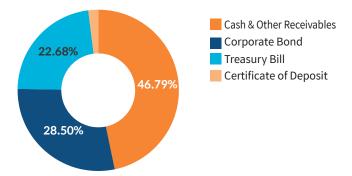

It highlights allocation to various debt instruments such as commercial papers (CPs), certificate of deposits (CDs), NCDs and bonds, gilts and cash equivalents.

Investors in shorter maturity debt funds such as liquid, ultra short term, short- term debt funds should check whether higher proportion has been allocated to shorter maturity instruments such as CPs and CDs. Sharpe Ratio:

Sharpe Ratio is a risk to reward ratio, it measures portfolio returns generated in excess to the investment in risk-free asset, for per unit of total risk taken. While, positive Sharpe ratio indicates, portfolio compensating investors with excess returns (over risk-free rate) for the commensurate risk taken; negative Sharpe ratio indicates, investors are better off investing in risk-free assets.

Beta:

Macaulay Duration (Duration):

Macaulay Duration (Duration) measures the price volatility of fixed income securities. It is often used in the comparison of interest rate risk between securities with different coupons and different maturities. It is defined as the weighted average time to cash flows of a bond where the weights are nothing but the present value of the cash flows themselves. It is expressed in years/days. The duration of a fixed income security is always shorter than its term to maturity, except in the case of zero coupon securities where they are the same.








