Rebalancing due to passive breach:

As per clause 3.5.4 of SEBI Master Circular dated June 27, 2024, the Scheme shall be considered to be replicating the index if the duration of the portfolio of the Scheme replicates the duration of the underlying index within a maximum permissible deviation of +/- 10%. Further, ETFs/Index Funds replicating a Constant Maturity index may invest in securities with residual maturity within+/-10% of maturity range of the index.

Post any transactions undertaken in the scheme portfolio, in or der to meet the redemption and subscription obligations, it shall be ensured that replication of the portfolio with the index is maintained at all points of time, subject to permissible deviations.

The Fund Manager would monitor the Tracking Error of the Scheme on an ongoing basis and would seek to minimize the Tracking Error to the maximum extent possible.

The annualized tracking difference averaged over one-year period shall not exceed 1.25%. In case the average annualized tracking difference over one-year period is higher than 1.25%, the same shall be brought to the notice of trustees with corrective actions taken by the AMC, if any.

- In case of change in constituents of the index due to periodic review, the portfolio of scheme shall be rebalanced within 7 calendar days.
- In case the rating of any security is downgraded to below the rating



mandated in the index methodology (including downgrade to below investment grade), the portfolio be rebalanced within 30 calendar days.

• In case the rating of any security is downgraded to below investment grade, the said security may be segregated in accordance with clause 4.4 of SEBI Master Circular dated June 27, 2024, on "Creation of segregated portfolio in mutual fund schemes.

Rebalancing of deviation due to short term defensive consideration:

The above mentioned investment pattern is indicative and subject to the SEBI (MF) Regulations, the asset allocation pattern indicated above may vary from time to time, on account of receipt of maturity proceeds, interest and/or receipt of subscription. As per SEBI Master Circular dated June 27, 2024 the Fund Manager, may deviate from the above investment pattern for short term period on defensive considerations. The same will be rebalanced within 7 Business Days and further action may be taken as specified under SEBI Circulars/ AMFI guidelines issued from time to time.

Tracking Error

The Scheme, in general, will hold all the securities that constitute the underlying Index in the same proportion as the index. Expectation is that, over a period of time, the tracking error of the Scheme relative to the performance of the Underlying Index will be relatively low. The AMC would monitor the tracking error of the Scheme on an ongoing basis and would seek to minimize tracking error to the maximum extent possible. Under normal market circumstances such tracking error is not expected to exceed 1.25% p.a for daily 12 month rolling return. However, in case of events like, dividend received from underlying securities, and market volatility during rebalancing of the portfolio following the rebalancing of the Underlying Index, etc. or in abnormal market circumstances, the tracking error may exceed the above limits. Since the Scheme is an exchange traded fund, it will endeavour that at no point of time the Scheme will deviate from the index.

Investment Strategy

The fund is a passively managed index fund which will employ an investment approach designed to track the performance of Nifty 8-13 yr G-Sec Index.

Pursuant to clause 3.5.4 of SEBI Master Circular dated June 27, 2024 replication of the Index by the Scheme shall be as follows

The Scheme shall be considered to be replicating the underlying index, provided: The duration of the portfolio of Scheme replicates the duration of the underlying index within a maximum permissible deviation of $\pm 10\%$.

ETFs/Index Funds replicating a Constant Maturity index may invest in securities with residual maturity within+/-10% of maturity range of the index

The Scheme will invest in Government Securities which are constituents of the underlying Index viz. Nifty 8-13 yr G-Sec Index. Based on the availability of issuances, it is expected that the portfolio allocation could be different than that of underlying index allocation and could result in Tracking Error. That said broad risk parameters of the portfolio of the Scheme such as credit rating, weighted average YTM, weighted average maturity, asset allocation etc. are expected to be similar to the Underlying Index.

The trading member will transfer the Units directly to his/her/ its beneficiary account on receipt of the same from NSE's/ BSE's Clearing Corporation.

An investor who has sold Units should instruct his/her/its Depository Participant (DP) to give 'Delivery Out' instructions to transfer the Units from his/her/its beneficiary account to the Pool Account of his/her/its trading member through whom he/she/it have sold the Units. The details of the Pool A/C (CM-BP-ID) of his/her trading member to which the Units are to be transferred, Unit quantity etc. should be mentioned in the Delivery Out instructions given by him/her to the DP. The instructions should be given well before the prescribed securities pay-in day. SEBI has advised that the Delivery Out instructions should be given at least 24 hours prior to the cut-off time for the prescribed securities pay-in to avoid any rejection of instructions due to data entry errors, network problems, etc.


