The Underlying Index is a free float adjusted market capitalization weighted index the objective of which is to represent the 30 largest technology companies listed in Hot Kong which have high business exposure to selected technology themes, including internet (including mobile), fintech, cloud, e-commerce, or digital activities. The technology companies selected have to be Greater China Companies (as defined below that are listed on the main board of the SEHK. The Underlying Index adopts a free float adjusted market capitalization weighted methodology, with an 8% cap on individue constituent weightings applied on the date of rebalancing. As such, the weighting of constituent may exceed 8% between rebalancing. The review of the Underlying Index is conducted quarterly.
