




# **Total AUM (Client Assets)**




# Overview of Assets Under Management globally (MAGI\*)

### Total AUM- USD 245 bn


# **AUM Breakdown**



# **AUM by Client Type**




# **AUM Growth Trend throughout the years**





### Net AUM Breakdown






