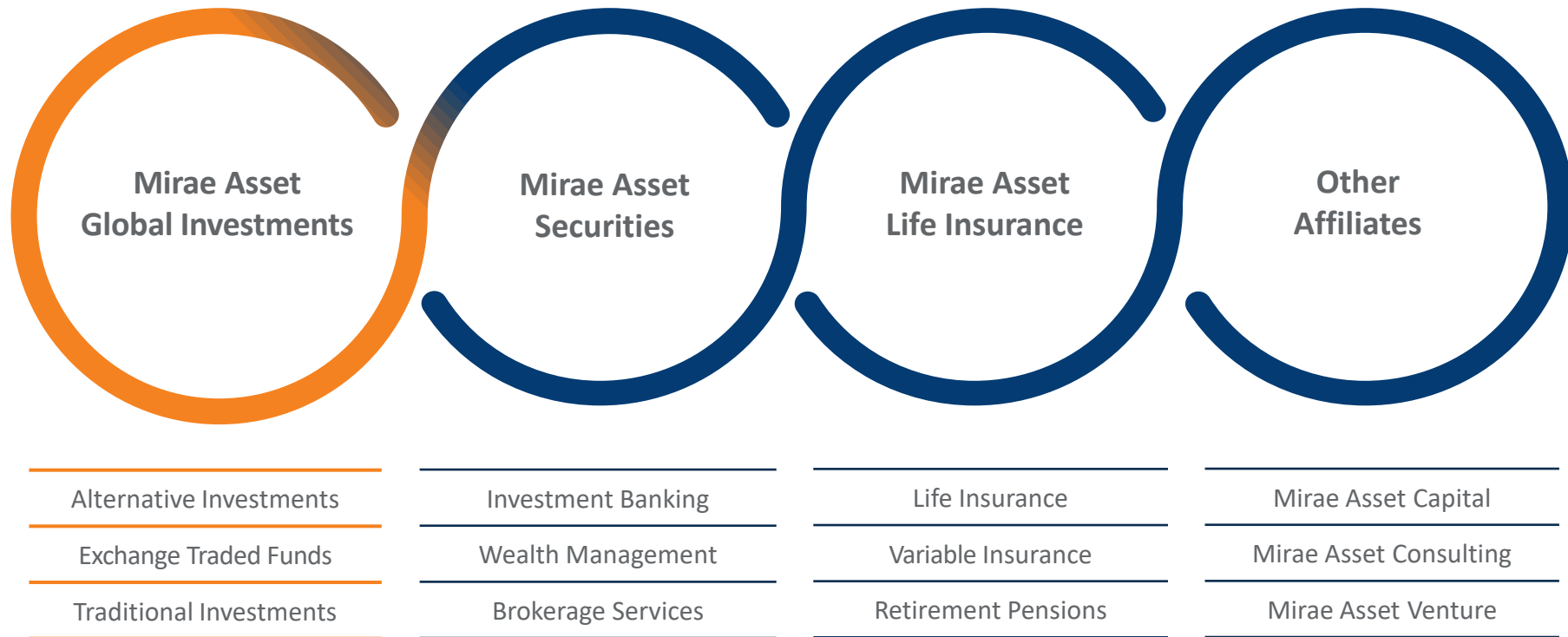

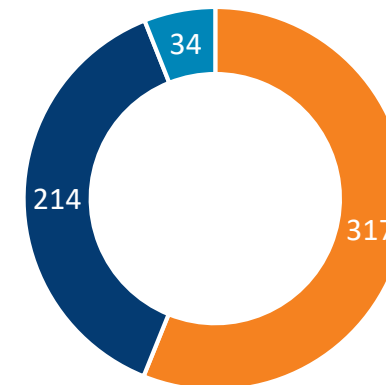

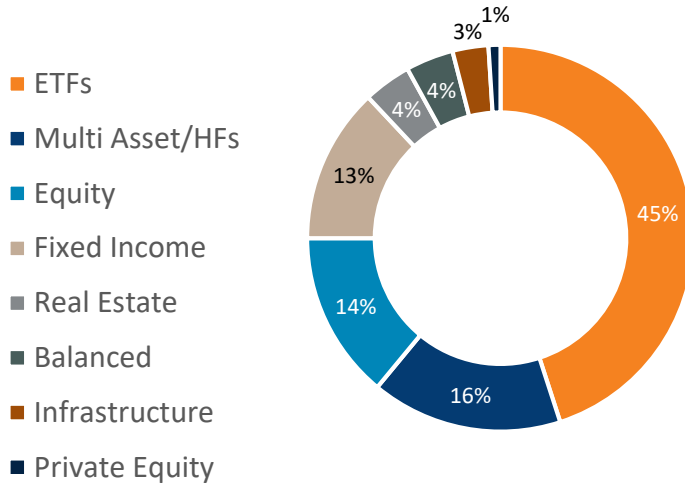

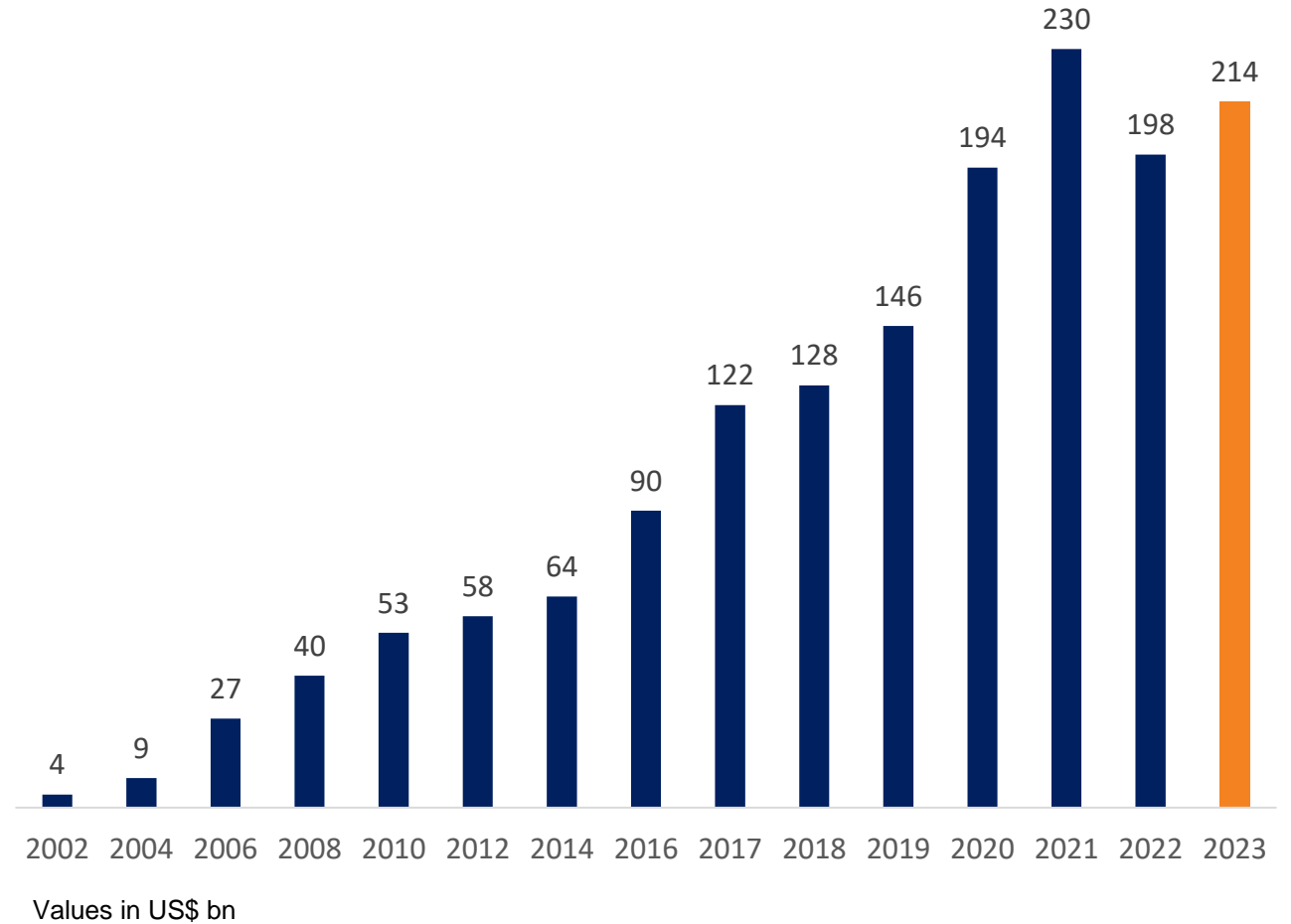
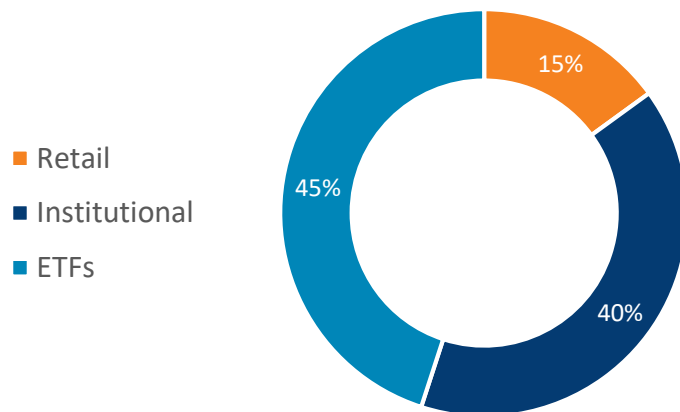

AUM Breakdown

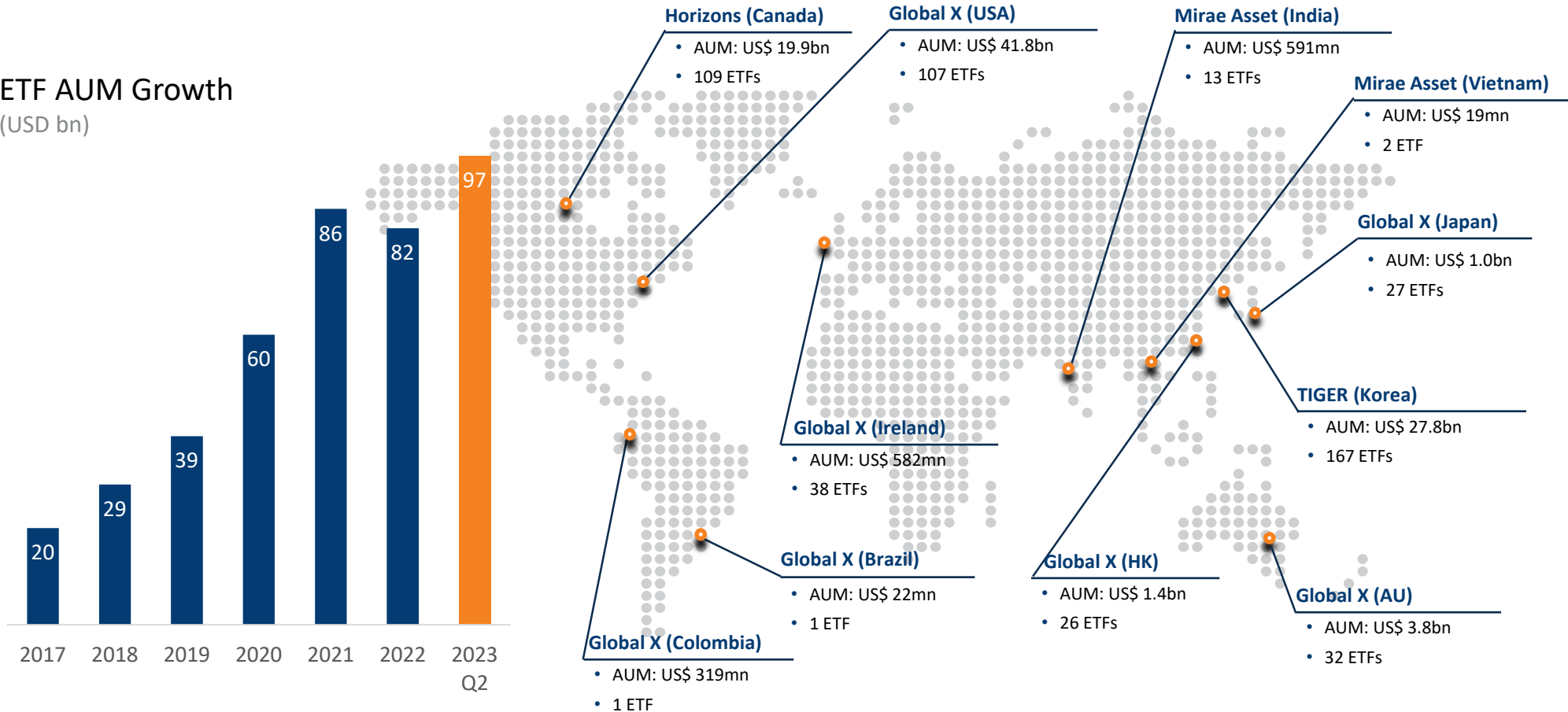


AUM by Client Type

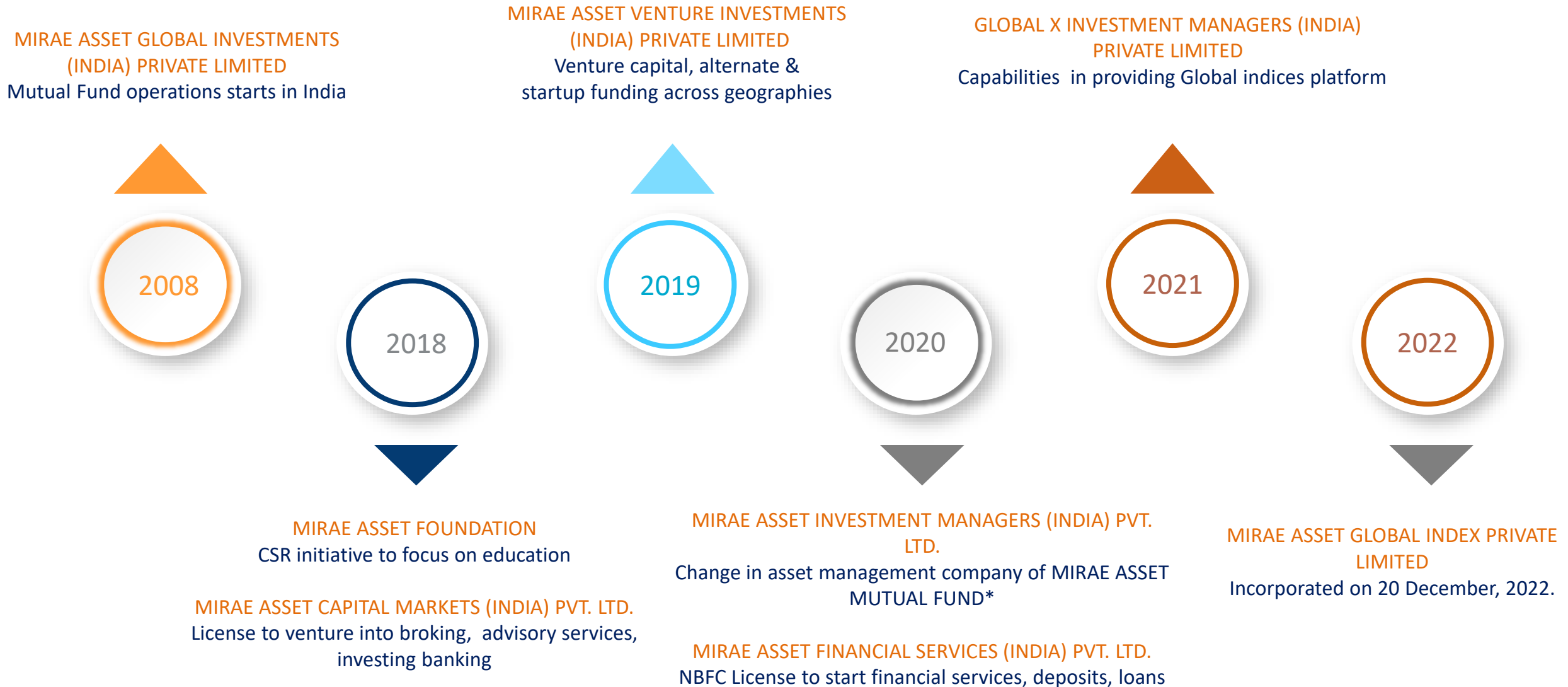

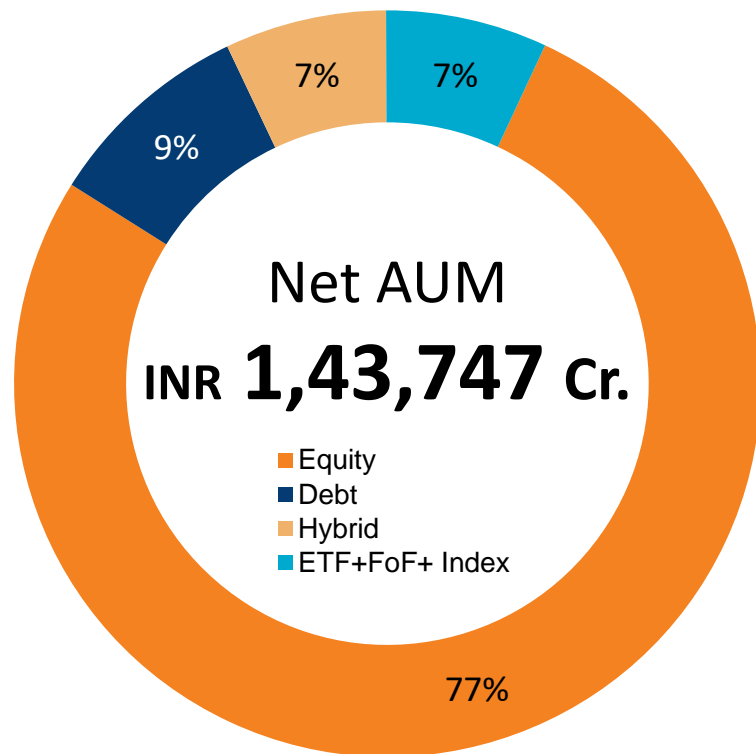

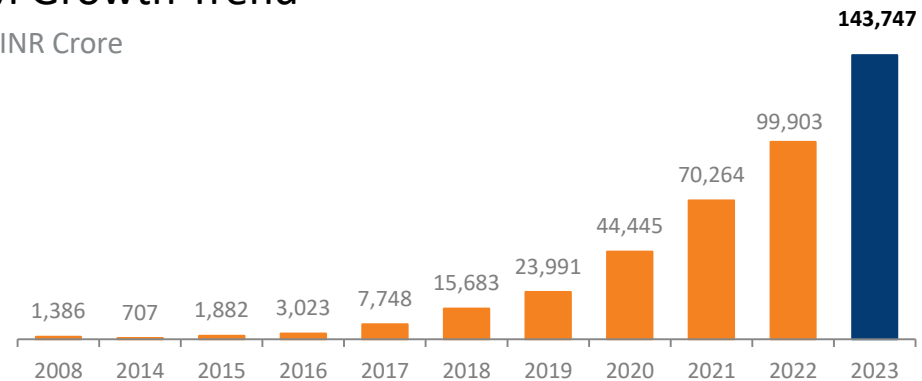
Mutual Fund AUM Growth

Net AUM Breakdown



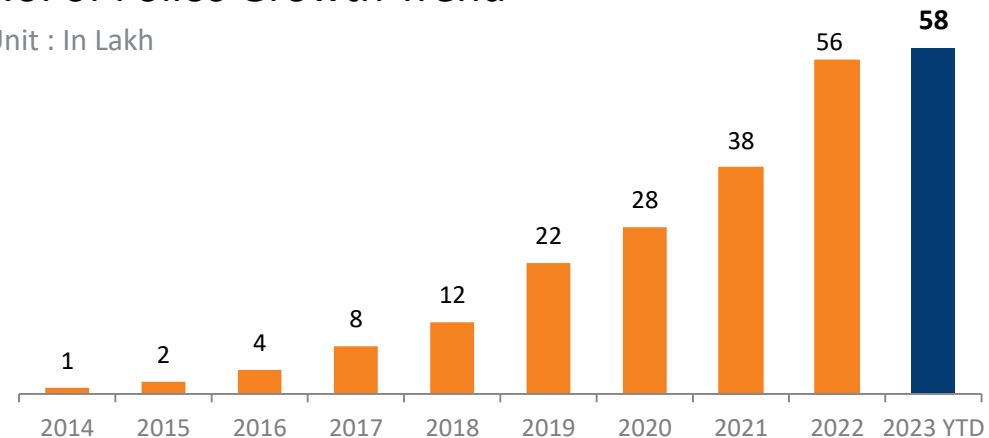
AUM Growth Trend
