Monthly Equity Market Insight



June 2023

EQUITY UPDATE

- Nifty-50 Index (3.5%) staged a spectacular rally to hit fresh all-time-highs above 19,000, as FIIs continued to invest in India with China macros continuing to disappoint.
- Mid-cap and small-cap indices outshined large-cap indices and were up by 6% and 7%. Sector-wise, all indices ended in green, with capital goods (+9%), healthcare (+9%) and realty (+9%) gaining the most.
- Globally, Brazil (+9%), Japan (+8%) and US S&P 500 (+7%) were the top gainers, whereas Russia lost 7%.

Global Macros

- Fed paused rate hikes: Fed paused its rate hike series in June; however median dot plot show 2 more rate hikes this year. US Consumer Price Index (CPI) was below consensus for May 2023 at 4.0%, however core inflation continues to be sticky. In Europe, European Central Bank continued to hike rates with 25bps hike in June and market expecting another rate hike of 25bps in July. Oil is up 3.5% MoM on production cuts by Saudi.
- Bond yield: The US 10-year bond yield increased to 3.84% as on June 30, 2023, from 3.64% as on May 31, 2023.
- **Crude:** Dated Brent crude spot price increased to US\$74.6/bbl as on June 30, 2023 from US\$72/bbl as on May 31, 2023 and future prices increased to US\$74.9/bbl as on June 30, 2023 from US\$72.66/bbl as on May 31, 2023


Domestic Macros

- **Growth:** Fitch raised India's CY24 GDP forecast to 6.3% (from 6% earlier) on the back of robust growth in Q1 and strong near-term momentum.
- Policy: The RBI Monetary Policy Committee (MPC), in line with market's expectations, voted unanimously to keep the repo rate unchanged at 6.5%. The policy repo rate has been increased by 250 basis points since May 2022 and is still working its way through the system with its fuller effects still to be completely seen in the remainder of the year. RBI said it would remain focused on withdrawal of accommodation to ensure that inflation progressively aligns with the target, while supporting growth. RBI's medium-term target for CPI inflation is 4% within a band of +/- 2%.
- Current Account Deficit / Balance of Payment (CAD/BOP): Current account moderated to -0.2% as a percentage of GDP in 4QFY23 from -2% in 3QFY23 led by narrowing of the goods trade deficit and robust net services exports. Current account in FY2023 widened to -2% of GDP (from -1.2% in FY2022). The capital account was volatile in FY2023 with reduction in net FDI flows at US\$28 billion. Accordingly, FY2023 BOP slipped into deficit of US\$9.1 billion compared to a BOP surplus of US\$47.5 billion in FY2022.
- **Credit Growth:** As per latest RBI data, system credit growth stood at 15.4% YoY for the fortnight ended June 16, 2023. So far, credit growth has been driven by continued and sustained retail credit demand, strong growth in NBFCs, and inflation-induced working capital requirement.
- Inflation: May 2023 CPI inflation moderated sharply to 4.25% (from 4.7% in April 2023) led by falling food inflation and favorable base effects. May Wholesale Price Index (WPI) inflation contracted by 3.5% from -0.9% in April 2023 led by favorable base effects and continued softening in commodity prices. Further, the RBI MPC maintained status quo in its June MPC meeting with the repo rate at 6.5% while continuing to focus on 'withdrawal of accommodation'.
- **Currency:** USD-INR has appreciated to Rs82.04/US\$ (as on June 30, 2023) from Rs82.73/US\$ (as on May 31, 2023) supported by FPI inflows and waning US Dollar strength (weighed down by relatively more hawkish European Central Bank and Bank of England). The INR has appreciated by 0.84% against the US\$ in June 2023.
- **GST Collection:** GST revenue collection in the month of May 2023 was at Rs 1.62 lakh crore, up by around 12% on an annual basis. With this, the monthly GST revenues has remained over Rs 1.4 lakh crore for 16 months in a row.
- Monsoon: Monsoon has covered all parts of India faster than expected despite the delayed start, however it has not managed to cover the deficiency which is ~9% till date. IMD expects a normal rainfall pan India, but uneven spatial distribution with likelihood of deficiency in Northeast and Northwest India with "high probability" of El-Nino conditions suggesting that monsoon risk remains.

Regulatory, policy and market developments

• Equity trading trends: FIIs were net buyers in the month of June 2023 to the tune of \$6.7 billion and DIIs bought to the tune of \$540 million.

Chart of the month: Significant improvement in Current Account Deficit (% of GDP)- Recently weakened energy prices and rising services exports has helped to reduce current account deficit.

MONTHLY EQUITY MARKET INSIGHT

Outlook

- In the final leg of rate hike cycle: India 10-year bond yield reduced from a 7.5% in October 2022 to 7.1% now, implying a peaking out of rate hike cycle. Global headline inflation has moderated in recent months, though core inflation continues to be sticky. Large interest rate hikes have helped reduce the negative real rates prevailing in most economies. However, it has come at the cost of a liquidity crisis in regional banks in the US. In this context, the overall markets now seem to be expecting a likely pause (if not decline) in rates in the coming months.
- Domestic macros stand out: Economic data has seen an uptick in May 2023/June 2023. GST collection in June 2023 was at Rs.1.6 trillion, growth flat at 11.6% YoY. Forex reserves have risen by US\$4 billion MoM and forex cover is reasonable at 10 months level. Inflation was further down by 40 bps MoM to 4.3%, 17-month low well within RBI tolerance range of 2-6%. WPI stood at -2.6% MoM and at -3.5% as 31-month lows. Bank credit growth despite falling WPI is still robust at 15.4% YoY as of 16th June 2023.
- Rural trends holding up, weak rainfall onset: Construction indicators were strong with steel consumption (+8% YoY) and cement production for May 2023 at +15.5% YoY. Housing rates have kept climbing and are now nearing a 10-year-high. Rural wage growth has held nearly 6% YoY levels for the past 6 months, higher than the ~4% levels seen pre-COVID. On the agriculture side, the government's summer crop Minimum Support Price hike of 7% for rice, was at a 5-year high. Monsoon season rainfall though has started off weak in June, has recovered in the last week of June (-10% vs. normal); July rainfall will be more important.
- Cyclical rebound helping India: Equity markets have faced 4 consecutive shocks in the last 2 years in the form of 1) COVID, 2) High inflation (disruption in global supply chains), 3) Geopolitics (Russia-Ukraine war) and 4) Sharp rise in interest rates. Indian economy has been able to withstand these shocks relatively better than other economies. This is led by a) Cyclical upturn in many sectors (Real estate, Auto, Banking, Telecom etc), b) Manufacturing tailwinds led by China+1 & PLI, c) Capex recovery (India Inc. Balance Sheets have strengthened) and d) Consolidation (formalization).
- Key things to watch out are: (a) Oil price trend, (b) rate trajectory by the central banks, (c) Russia-Ukraine war and its impact on global supply chain and (d) Risk of El Nino on monsoons
- Over the medium term: we continue to remain constructive on equities and believe India is on the cusp of achieving robust growth over the next few years. Higher capex provisioning and benefits from PLI (potentially can add 1.5% to GDP over the next 5 years) should potentially revive overall capital expenditure across the sectors, boost employment as well as credit growth.
- Valuation and view: India's medium to long term growth prospects remain strong. While markets have rebounded from recent lows and hit all-time highs, valuations are still palatable at ~20x on FY24 and ~17.5x on FY25 earnings. While domestic macro gives support at a broader level, at a sectoral level several financials, select autos and pharma trade at a discount to historical average valuations.

DEBT UPDATE

Executive Summary

The overarching theme for both the global real economy and the financial markets for the past few months has been the tectonic shift from a world of abundant liquidity to one where liquidity is being drained at an unprecedented speed and intensity. A few economies have started showing sign of distress in the form of negative growth a few are still being resilient.

Indian economy so far has shown resilience as per the high frequency data. However, globall slowdown might have a spillover effect on the future. health of the economy.

H1 (First Half) 2023 Snippet

Completion of June-23 also coincides with completion of first six months of 2023. A few major events which happened in the first half of 2023 were:

- Several major US regional bank failures.
- A last-minute rescue of a 167-year-old Swiss bank by its historical rival.
- A German recession.
- US credit default swaps (CDS) exploding to 175 basis points (bps) from 15bps, on fears over the debt ceiling.

In 2022 central banks globally had unified objective of bringing inflation down and resultantly almost every central bank pushed the rate hike pedal. However, so far in 2023 each central bank is reacting differently. The likes of Canada and Australia paused rate hikes only to raise it due to inflationary pressures. Bank of England hiked rates 13 consecutive times. The US Fed after a steep hike cycle paused only to revise estimated terminal rate for 2023 upwards, signaling another hike. While Eurozone has entered into a recession, US has so far avoided recession.

Global Macros


Federal Open Market Committee's (FOMC) outcome of June-23 meeting to pause further hike in interest rates provided much relief, the hawkish undertones of the US Fed Chairman suggested otherwise. That along with upward estimation of terminal rate forecast at 5.6% for calendar year 2023 vs 5.1% done previously in FOMC meeting of Mar-23, makes a strong case for another potential rate hike. Unlike their US counterpart, Bank of England (BoE) & European Central Bank (ECB) raised interest rates at the back of high inflation data.

Gross domestic product (GDP), of the US economy expanded at a much faster pace in the first quarter (Q1) of 2023 than estimated. GDP rose by an annualized rate of 2% in Q1 2023 reflecting resilient consumption in the face of higher interest rates. Not only the GDP but US labor market have also been resilient so far. The wage growth and job openings saw an uptick for two consecutive months. If the labor markets continue to remain strong, it may become catalyst for future policy decisions.

On the other hand, the Eurozone economy contracted in Q1 2023. High inflation and rising borrowing costs eroded the purchasing power of many European households over the past year, but there are signs that rising wages and falling energy prices lead to a consumption boost in the coming period. Pointing to a strong probability that the overall Eurozone GDP may return to growth after two consecutive quarters of contraction.

The U.S. Treasury yields increased in June-23 and the yield curve inverted amid hawkish central bank rhetoric and mixed economic data. Making short end yields higher than long term yields. However, in comparison to May-23, the short end yields increased. Fixed income markets in general have registered positive gains

albeit with periods of volatility and weakness in specific segments, notably longer dated bonds.

Commodity markets have faced a more difficult backdrop with the uncertain economic outlook and concerns over slowing Chinese demand weighing on energy and copper prices. In contrast gold has benefitted from its safe haven attribute in first half of 2023.

Domestic Macros

The broader economic landscape remains a mixed picture. The S&P Global India Manufacturing PMI (purchasing managers index) decreased to 57.8 in June-23 from 58.7 in May-23. Services PMI also decreased to 58.5 in June-23 from 61.2 in May-23. However, Index for Industrial Production (IIP) for Apr-23 (released in June-23) surprised positively with 4.2% YoY growth vs a meagre 1.7% for Mar-23. Consumer Price Index (CPI) inflation print for May-23. (released in June-23) came in at a softer 4.3% (vs 4.7% in Apr-23). The Wholesale Price Index (WPI) had sunk deeper into deflation (-3.5% vs. -0.9%).


Commentary on Events

Three drivers steering lower inflation:

- India's WPI, which has a higher weight for items linked to global prices, has seen wild swings in the aftermath of the pandemic and geopolitical tensions.
- Broadly, a fall in global energy prices and commodity prices have played a huge role in easing pressures on WPI inflation.
- A third factor which has started to play a significant role is the easing of global supply chains. The New York Fed's Global Supply Chain Pressure Index declined for the fifth month straight to an all-time low, indicating significant resolution of stress.


Debt Outlook

How to read a Mutual Fund Factsheet?



Know how your money is managed

The benefits of investing in mutual funds are well known. However, buying them on face value is not enough. Investors should know how their money is managed. They should research as much as possible on a scheme's strategy, performance, risks involved and how the money is invested. Many investors shy away from this exercise as they consider it cumbersome. To make life easy for investors, mutual funds disclose a fund factsheet which details the quintessential information required before investing.

The factsheet is a concise document with a plethora of information about how the fund is managed; it is disclosed on a monthly basis. This article tries to decode the factsheet and explains how investors should use it for making investment decisions.

Five things to look out for in mutual fund factsheets




Basic information

The factsheet provides all the general information on the funds its objective or philosophy, options (growth or dividend), plans (direct and regular), net asset value (NAV) of each plan, minimum investment amount, systematic features (SIP, SWP, STP) and assets under management (AUM) data.

It is important to know about the fund's exit load, as it gets deducted from total gains if the investor exits during a specific period after investment. It is a small penalty charged on prevailing NAV to discourage premature redemption. Different schemes have different exit loads, while few such as Overnight funds generally do not have exit load. Some funds have a fixed exit load and some have a tiered structure. For instance, a fund may have nil exit load if the investor withdraws up to 10% of units per year. For units more than 10%, it charges 3% for exit before 12 months, 2% for exit before 24 months, 1% for exit before 36 months and nil after that.

Investors should look out for the fund's product labeling and riskometer. Product labeling underlines product suitability for investors. It tells about ideal investment time frame required to benefit from the fund and where it invests. Riskometer is a presentation that helps investors measure the risk associated with the fund. It presents six levels of risks - low, Low to Moderate, moderate, moderately High, High and Very High. Since an equity fund typically has high risk involved, needle of the scale points towards moderately high /high, suggesting the fund is meant for investors with a high risk-taking appetite. 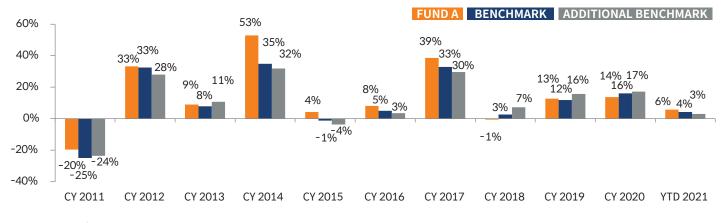

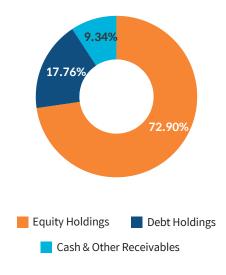

An aggressive fund manager may have high concentration among fewer companies and sectors, which may not be appropriate for investors seeking diversification. Investors should check whether the fund has taken higher-than-prudent exposure to risker sectors or low quality stocks.


Key portfolio attributes to look for in debt funds

Credit quality profile

A debt fund's holdings are classified according to its credit ratings such as AAA, AA+, A1+ (given by credit rating agencies), etc.

Funds with higher exposure to AAA (top rated long-term debt) and A1+ (top rated short-term debt) have lower credit risk and higher credit quality.

Conservative investors should check whether the fund manager in order to boost performance is taking undue exposure to lower rated debt papers as they typically trade at higher yields but are exposed to high credit and liquidity risk vis-à-vis top rated papers.

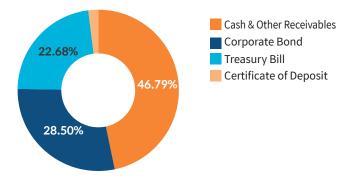

It highlights allocation to various debt instruments such as commercial papers (CPs), certificate of deposits (CDs), NCDs and bonds, gilts and cash equivalents.

Investors in shorter maturity debt funds such as liquid, ultra short term, short- term debt funds should check whether higher proportion has been allocated to shorter maturity instruments such as CPs and CDs. Sharpe Ratio:

Sharpe Ratio is a risk to reward ratio, it measures portfolio returns generated in excess to the investment in risk-free asset, for per unit of total risk taken. Macaulay Duration (Duration) measures the price volatility of fixed income securities. It is often used in the comparison of interest rate risk between securities with different coupons and different maturities. It is defined as the weighted average time to cash flows of a bond where the weights are nothing but the present value of the cash flows themselves. It is expressed in years/days. The duration of a fixed income security is always shorter than its term to maturity, except in the case of zero coupon securities where they are the same.














